#### Welcome from the Vice-Chair

The Vice-Chair called the meeting to order at 3:04pm ET and delivered a land acknowledgement statement

The Vice-Chair then invited the incoming Don of Hall to delivery introductory remarks.

The Don of Hall remarked:

To sum, as Don of Hall, I wanted to remind us that many of us have the privilege of coming to this space where education is a restorative venture. For many Indigenous people on Turtle Island, education is a context of trauma



and the continuation of settler colonial violence. In light of the ongoing recovery of unmarked graves in residential schools across this land, I wanted to prompt the board to be mindful of who their words and actions, in the context of education, do to reproduce and potentially resist these histories of violence. And that the next steps include not only discursive gestures, but material and meaningful action.

## Report of the Principal

The Principal thanked the Vice-Chair and delivered the following report:

**Staffing** – Principal Des Rosiers welcomed Ms. Catherine Fowler the former Director of Advancement and newly appointed Chief Administrative Officer. The Principal also welcomed Alyssa Ginsburg the new Digital Events Coordinator. She informed the board that she is in the process of recruiting a new Head Porter and Director of Advancement.

**COVID 19** – The College's current COVID-19 protocol will remain the same, Massey College continues to strictly adhere to all public health guidelines.

**Junior Fellows** – The Principal updated the board on application, demographic and admissions numbers for the incoming cohort of Junior Fellows. She reported on changes to bursaries available to students and was pleased to note that the College is able to offer some support all Junior Fellows in need. Principal Des Rosiers communicated that she is also in the process of implementing and recognizing the skills development needed by the Junior Fellowship and is moving to a process of creating formal programs that she hopes to have in place for September 2021.

**Programming** – The Principal and College staff are preparing for the fall to provide a variety of intellectual programming that will engage the community. The Principal then outlined three new residencies starting at the college in September 2021– Social Changemaker, Diplomat and Filmmaker in Residence.

**Anti-Black Racism Council-** the Anti-Black Racism Committee continues its work on the celebration of Black scholarship at Massey College as well as data collection, focusing on equity data and how to communicate, share and measure it effectively.

**Finances -** The Principal reported that CBC has renewed their funding commitment for a CBC Radio-Canada Fellow as a part of the William Southam Journalism Fellowships held at Massey College. She is also working on a federal grant to fund an additional civic or local journalism fellow to run in tandem with the William Southam Journalism Fellowships.

The College continues to eligible for Federal support, and hopes for increased catering and event revenues coming into the fall.
