Report from the Don of Hall

There has been a great response to the events and programming – especially around the High Tables celebrating Pride and Muslim Communities. They also updated the Governing Board on the activities of the Junior Fellow House Committee and governance initiatives in process.

Report from the Chair of the Governance and Nominating Committee

Report of the Risk Committee

The Chair of the Risk Committee, Pankaj Mehra updated the Governing Board on the activities of the Risk Committee – the committee met in August, as well as November 24th. They continue to monitor COVID protocols and public health guidelines from the province and work closely with Principal Des Rosiers in regards to College COVID protocols. Mr. Mehra then briefed the board on the update to the Massey College Bylaws, as well as the Risk Committee's work on mental health supports for the Junior Fellowship.

Report of the Alumni Representative

Mr. Wanekia Dunn gave a short report on the activities of the Massey College Alumni Association (MCAA) - dinners by alumni cohort have been well received and were well attended. The MCAA continue to work on Alumni outreach. Mr. Dunn will send a report to the board following the association's next meeting early in 2022.

Report of the Chair of the Finance and Audit Committee

In Mr. Casgrain's absence, The Principal invited the Governing Board to review the Bursar's Report which was circulated to the Board in advance of the meeting. The Principal also highlighted that the Finance and Risk Committee is currently evaluating Massey College's investment managers and are preparing a call for proposals.
